Meeting called to Order at 12:07 p.m.

1. <u>Minutes.</u> Approve minutes from the previous meeting(s).

The August meeting minutes were presented by Mr. Joyce. After review, a motion was made by Director Barner to approve the August meeting minutes, as presented. Director Blanco seconded the motion, which passed unanimously.
