


#### Rail Corridor Collaborative

- Discuss mechanisms to reduce railroad impacts to safety and mobility






## Rail Safety Taskforce




## Smart Railroad Sensors



## Safe Routes

- Identify hazards along essential routes in proximity to crossing
  - School
  - Clinic
  - Community Center
  - Food Store
- Conduct studies for treatments to reduce impacts
  - Abatement
  - Operational Changes
  - Infrastructure Improvement
  - Awareness/Education





#### Road Safety System Traffic Injury Research Foundation

- Surveyed 12 neighborhoods in the East Houston area
- Diverse stakeholders: teachers, first responders, city council offices, business owners, professional drivers, and residents
- Key Takeaways
  - Lack of consistency in road safety activities
  - Limited awareness of safety programs
  - Siloed data sharing efforts
  - No identified funding mechanism

## Road Safety Concerns



- Unsafe railroad crossings
- Unsafe sidewalks and bicycle lanes
- Speeding
- Limited or no infrastructure to make roads safer
- Improper or no road maintenance
