

 - Focus Safety Funding












Rail Safety Taskforce

Canadian Pacific Acquisition of KCS



- Opposition Letters Filed from EED, CM Gallegos & RSTF
- Surface Transportation Board- Houston
 - •5900 Market Street,
 - •7000 Market Street Port Terminal Railway (frequently stalled crossing)
 - Englewood Yard
 - •2000 Lyons (emergency access route)
 - •Blocked crossing impacts on emergency response (HFD #18)
 - •Railroad Crossing Elimination Grant potential site (800 York)
 - •Coffee & roundtable with local community leaders (Segundo Coffee Lab)



Safe Routes

- Identify hazards along essential routes in proximity to crossing
 - School
 - Clinic
 - Community Center
 - Food Store
- Conduct studies for treatments to reduce impacts
 - Engineering Study
 - Waiting on priority list from DON
