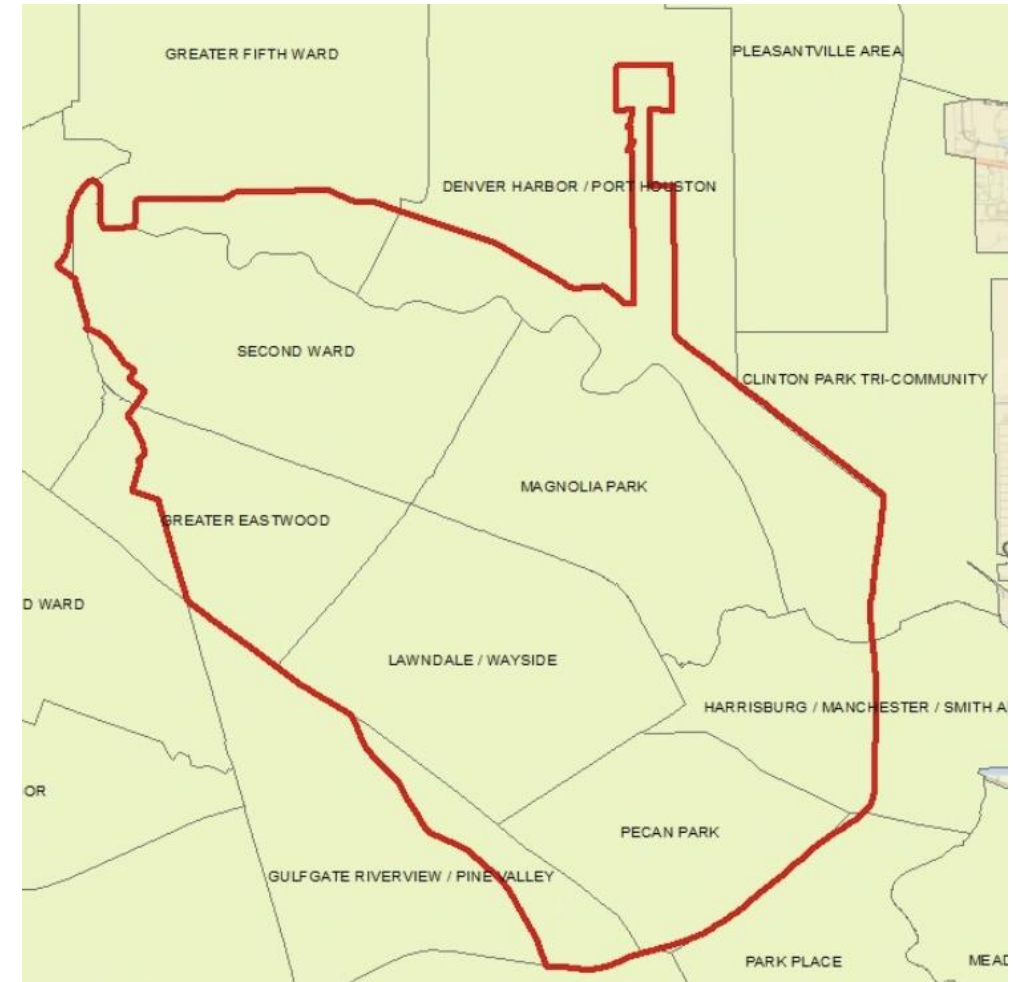

Rail Corridor Collaborative

Personnel from the East End District and Houston Emergency Services meets monthly with the four operating railroads to discuss impacts to safety and mobility along railroad corridors:

Reported Events that affected Safety and Railroad Operations:

- December 2, 2025 – Emergency Crossing Closure at Durham Street for broken rail repair
- December 2, 2025 – Emergency Crossing Repair at Lockwood for broken rail repair
- December 8, 2025 – Emergency Crossing Repair at T.C. Jester for broken rail repair
- December 11, 2026 – Scheduled Crossing Repair at T.C. Jester
- December 12, 2026 – Stopped Train Event Commerce Street due to trespasser on track
- December 13, 2026 – Train-Vehicle Crash at Post Oak Boulevard
- December 16, 2026 – Stopped Train Event on Lockwood due to vehicle stuck on tracks



Data Convergence

Safe Streets Projects

- FY22 EED funds created a Safety Action Plan – posted on EED Website
- FY24 EED Supplemental Planning and Demonstration Award of \$895,000 in grant has been obligated; project is to start in late January 2026
- FY24 Houston HFD Post Crash Care - \$3.4 Million to expand the railroad crossing monitoring project is awaiting obligation of funds by the Federal Highway Administration
- FY25 EED Supplemental Planning Bike/Ped Access – a request was made to fund a study in Second Ward.



Spring 2026 Capstone Projects

In Spring of 2026, students from the Institute of Industrial and Systems Engineers are being requested to perform the following studies in the East End:

- District Gateway Traffic Demand - identify impacts and projected traffic demand caused by environmental conditions and evolving infrastructure changes such as drainage improvement and road closures within transportation network that affects access to the East End District
- Railroad Crossing Catalog - develop a process and criteria for creating at grade railroad crossing catalog that identifies risk, infrastructure needs, and project readiness to improve safety.

TRANSPORTATION SAFETY

As a community effort to address transportation challenges, the East End District is implementing a comprehensive strategy focusing on transportation safety, quality of life and mobility throughout the district. Key initiatives include: creating a comprehensive safety action plan, identifying traffic flow impediments such as blocked railroad crossings, damaged crossings, inadequate pedestrian access, and malfunctioning traffic control devices.



MISSION

The East End District provides services and conducts capital improvement throughout the 16 square miles of the District. The services, funded by assessment paid by commercial property interests throughout the District, include public safety programs, graffiti abatement, maintenance of major thoroughfares, and disposal of illegally dumped trash.
